Crockenhill 100 Club Rules

1. Each member will be allocated a designated number. The number remains your own as long as you remain a fully paid up member. You may buy more than one subscription and will be allocated a different number for each one. The club is not limited to 100 members.
2. There is no restriction on the number of members from any one family or group of friends. All members must be 16 years of age or over, and have a bank account.
3. The subscriptions will be £5 per month payable by standing order only on the 1st of each month. All monies will be handled in a separate bank account
4. A draw will take place on the last weekend of each month for cash prizes. Winners of prizes will be paid by cheque either in person or by post. Results will be announced on the club website and in the match day programme.
5. A maximum of 50% of the total monthly subscriptions will be paid out in cash prizes. 50% of the total monthly subscriptions will go to Crockenhill F.C for maintenance and improvements to the ground.
6. In the month of December a maximum of 60% of the monthly subscriptions will be paid out in cash prizes.
7. The draw will be conducted in the presence of at least one committee member.
8. Any default of payment will render that member ineligible for future draws.
9. Members can cancel their entry in to the draw by giving one month's written notice to the club and advising their bank accordingly. Any decision by the club to wind up the draw will also be by one month's written notice. Under no circumstances can any payment be refunded.
10. The decision of the club committee shall be final in any matter of adjudication. The club committee shall have the powers to add to, amend or remove any of the aforementioned rules.
